VI's Point Protection Option (PPO)

What percentage of Americans claim that they have to cancel trip plans regularly? 42%! Usually, it is only a few weeks before departure.

We don't want you to lose all of your points if something comes up that forces you to cancel your trip. VI's Point Protection Option (PPO) offers you a 100% refund of VI Points* if cancelled by 4pm (Pacific Time) on the last business day prior to your arrival date! In addition, when you purchase PPO at the time you book your reservation, you can make changes to your existing reservations without incurring any additional bookings fees.

The Facts:

- PPO can be purchased for \$45 at the time of booking for reservations using VI Points traveling to a VI resort.
- When booking a reservation online, you can select to have PPO applied to your VI resort reservation at the time the reservation is requested. The non-refundable fee is due immediately or your reservation will not be covered by PPO.
- PPO cannot be purchased for an existing reservation, any exchange reservation, or a reservation confirmed using anything other than condo points.

If you need to cancel your reservation, your PPO coverage is activated when you call Owner Services at 1.800.444.6633 by 4pm on the last business day prior to your arrival date.

Owner Services Hours of Operation are: Mon, Wed, and Fri 8 am – 7 pm PST and Tue and Thu 9 am – 7 pm PST.

*Points are returned to the Use Year from where they originated.

VI Insider Tip

- Use the VI website 'search by location' feature, located on the Instant Exchange availability page. This feature assists you in finding weeks available at your chosen location.
- Check your VI Point balance before you book an exchange reservation with an outside trading company (RCI, II, etc.). Your exchange reservation won't be booked to your VI account for several weeks and if you are short on points, your account will be charged for VI rental points. Check your point balance first to make sure you are not surprised with any cost.
- Instant Exchange fee: \$145 to confirm a week. Once confirmed - reservations cannot be cancelled, changed, or refunded.
